



2025 NAHB International Builders' Show® BuilderBooks \$500 Cash Challenge Game

Official Rules—NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning.

1. A total of three (3) drawings will be held during the 2025 International Builders' Show, one (1) drawing each day at 3:00 PM on February 25-27, 2025 ("Daily Drawing"). Each Daily Drawing will be conducted using the entry forms submitted that day.
