

## **2025 NAHB Young Professionals IBS Sweepstakes**

**Official Rules**—NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning.

- 1. National Association of Home Builders of the United States ("NAHB") Young Professionals (YP) will award two (2) \$500 Pre-Paid Visa Gift Card (the "Prize") at the 2025 NAHB International Builders' Show (IBS) Prizes will be given away in a random drawing from all eligible entries received. The retail value of each Prize is \$500. The odds of winning will depend on the number of eligible entries received.

To enter the Sweepstakes, visit the NAHB Head Quarters (HQ) Booth located in the Central Hall, Grand Lobby, Level 1 at IBS on any day between Tuesday, February 25, 2025, and Thursday, February 27, 2025, between the hours of 9:00am 5:00pm to receive an entry form. Complete an entry form and drop it off at the NAHB HQ Booth before 5:00 p.m. on Thursday, February 27, 2025. Limit one entry per person. NAHB reserves the right to disqualify any incomplete entries.
- 3. Two entry forms will be pulled out of the entry box via a random drawing by an NAHB Representative at 5:00 PM on Thursday, February 27, 2025 and the persons identified on the entry form will be declared the Winners of the Prize (\$500 Visa Gift Card). The Winners will be notified after 5:00 p.m. on Thursday, February 27 via email and phone call. The return of any prize notification or prize as undeliverable may result in disqualification and an alternate winner may be selected. At that time, winners can pick up the Prize at the IBS Show Office's (LVCC N251). If they are not able to pick up the prize that day, an NAHB staffer will coordinate with the winner to email the required NAHB Declaration of Eligibility Release form which must be completed before the prize will be mailed to the winner. Each Prize award is separate and independent of the other Prize awards.
- 4. The determination of the Winner made by the NAHB Representative is final. The Winner may be required to execute a declaration of eligibility and release, which may be included as part of the entry form.
