



BuilderBooks \$500 Cash AI Challenge Game

Official Rules and Restrictions

1. NO PURCHASE IS NECESSARY TO ENTER, PLAY OR WIN.

A Purchase Will Not Increase Your Chances of Playing or Winning.

2. HOW TO ENTER: To enter the "BuilderBooks \$500 Cash AI Challenge" ("Sweepstakes"), you must be 18 years old or older at the time of the Daily Drawing, pick up an official entry form ("Entry Form") between February 17, 2026 and February 19, 2026 at The IBS Store located in the Hall D Lobby, Booth W55 of the Orange County Convention Center in Orlando, Florida ("IBS Store") between 2:45 p.m. - 2:59 p.m. each day, and print your name, company name, address, phone number and e-mail address on the Entry Form. The Entry Form must be completed, **handwritten** (no stickers or stamps), and dropped in the BuilderBooks \$500 Cash AI Challenge drawing drum ("Dropbox") located in the IBS Store, no later than 2:59 p.m. on the day of the Daily Drawing. A new Entry Form must be submitted each day. Only original copies of the official entry form will be accepted (no copies). Illegible and/or incomplete entries will not be accepted. The National Association of Home Builders of the United States ("NAHB") is the Administrator of this Sweepstakes. Limit one prize per household.

The person who answers the most questions correctly will be redeemed the winner. If there is a tie, the



players will choose an envelope, and one envelope will have the \$500 cash inside. The envelopes will be placed randomly each day.
