



# BuilderBooks Free 2027 IBS Registration

## Official Rules and Restrictions

### 1. NO PURCHASE IS NECESSARY TO ENTER, PLAY OR WIN.

A Purchase Will Not Increase Your Chances of Playing or Winning.

**2. HOW TO ENTER:** To enter the "Free 2027 IBS Registration Sweepstakes" ("Sweepstakes"), you must be 18 years old or older at the time of the drawing, complete the entry form found in the IBS Passport ("Entry Form") by printing by hand your name, company name, address, phone number, and e-mail address on the Entry Form, and then dropping the completed Entry Form in the Free 2027 IBS Registration Sweepstakes Box that will be located in the IBS Store. Entry Forms must be submitted by 5:00 p.m. each day in order to enter into that day's Daily Drawing. You may enter the Sweepstakes as often as you like, however, to enter each Daily Drawing, a new Entry Form must be submitted each day. Only original copies of the official Entry Form will be accepted (no copies). Illegible and/or incomplete Entry Forms will not be accepted.
