



2026 IBS – Daily Member Savings Giveaways at NAHB HQ

Official Rules and Restrictions

1. NO PURCHASE IS NECESSARY TO ENTER, PLAY OR WIN.

A Purchase Will Not Increase Your Chances of Playing or Winning.

2. HOW TO ENTER: To enter the “Daily Member Savings Giveaways at NAHB HQ” (“Sweepstakes”), you must be 18 years old or older at the time of the Daily Drawing, visit NAHB HQ between 8:00 a.m. and 5:00 p.m. between Tuesday, February 17, 2026 and Thursday, February 19, 2026 (“Sweepstakes Period”), and have your IBS registration badge scanned (“Badge Scan”) upon entry of NAHB HQ Booth. Attendees may Badge Scan on each day during the Sweepstakes Period, however, only one (1) Badge Scan per attendee per day will be counted as a valid entry. The National Association of Home Builders of the United States (“NAHB”) is the Administrator of this Sweepstakes.

3. ELIGIBILITY: This Sweepstakes is open only to persons who are 18 years of age or older and who are citizens or legal residents of the United States, except those employees (and their immediate family members and others living in the same household) of the following companies are not eligible to win: NAHB, Orange County Convention Center, Freeman Decorating Company, NAHB Exhibitor Appointed Contractors, INTERNATIONAL BUILDERS’ SHOW® (“IBS”) contractors and/or sub-contractors, and their promotional and/or advertising agencies. For each Daily Drawing, one (1) first-place winner will receive a \$1,000 Lowe’s digital gift card, one (1) second-place winner will receive a \$300 HotelPlanner digital gift card, and one (1) third-place winner will receive a \$250 Best Buy Business digital gift card.
