

## The 2024 NAHB Young Professionals IBS Sweepstakes

Official Rules and Restrictions—NO PURCHASE IS NECESSARY TO ENTER, PLAY OR WIN.

A Purchase Will Not Increase Your Chances of Playing or Winning.

- 1. NAHB Young Professionals (YP) will award one (1) Pre-Paid Visa Gift Card (the "Prize") for each day at the 2024 NAHB International Builders' Show (IBS), for a total of three (3) Prizes. One (1) Prize will be given away in a random daily drawing as described in Paragraph 4) below from all of the eligible entries received during the day of the drawing. The retail value of each Prize is \$500. The odds of winning will depend on the number of eligible entries received for each daily drawing.
- 2. To enter the Sweepstakes, you must visit the Young Professionals (YP) station at the NAHB HQ Booth, Central Hall, Grand Lobby, Level 1 at IBS on any day between Tuesday, February 27, 2024, and Thursday, February 29, 2024, between the hours of 9:00am 4:15pm.
- 3. To enter the Sweepstakes, you must be scanned by the official Sweepstakes Scanner located at the YP station of the NAHB HQ Booth. To be eligible for a daily drawing, you must complete certain information on your IBS registrant's profile, which may include a declaration of eligibility and release. You may be scanned only once (1) for each day's drawing. Duplicate scans will be removed from the list of eligible entrants. NAHB reserves the right to disqualify any incomplete entries.
- 4. At the time of the daily drawing, 4:30pm, at the YP station of the NAHB HQ Booth, an entry form will be pulled out of the entry box and the person identified on the entry form will be declared the Winner of that day's Prize (\$500 Visa Gift Card). The Winner must be present at the NAHB Headquarters Booth (Central Hall, Grand Lobby, Level 1) at the time of the daily drawing to win. Each Prize award is separate and independent of the other Prize awards. A Winner of a previous day's drawing will not be eligible to win the drawing on a subsequent day.
- 5. The determination of the Winner made by the NAHB Representative is final. The Winner may be required to execute a declaration of eligibility and release, which may be included as part of the entry form. If a Winner fails to comply with this requirement or does not satisfy the eligibility requirements described in Paragraph 6 below, then such Winner will not be eligible to win and an alternate Winner will be chosen. The Prize is non-transferable and cannot be substituted. Taxes, insurance and other fees associated with the Prize are the sole responsibility of the Winner of the Prize. By participating in the Sweepstakes, entrants agree that NAHB and NAHB's representatives, agencies, affiliates, subsidiaries, officers, directors, members and employees shall not have any liability for any injuries, losses or damages of any kind caused by the Prize or resulting from acceptance, possession or use of the Prize. By participating the Sweepstakes, entrants accept and agree to these rules and the decisions of the NAHB Representative as final and certify that they are eligible for the Sweepstakes.
